15 MINUTES PROGRAM REPORT JUDY DETTMER

DISCUSSION	REVNUE REPORT:  Revenue report – Regina Rodriguez - Spending Authority \$3,311,937 money which the program is allowed to spend. On average we bring in between \$2 and \$2.2 million dollars each year in revenue  This year the program budgeted for 2 million, and projected that the Trust Fund generates on average between \$140,000-\$150,000 monthly in revenue which will be at \$2.1 million this year  Catie – if we are getting money from marijuana related traffic offenses. Judy indicated that we don't know because they are with all DUI/DWA surcharges  Payment for surcharges could be a two year lag time or more  Wendy asked if most of the revenue comes in early in the year, or if we are collecting pretty continually? Do we expect that the last three months will be greater than \$140,000? Regina indicated the last part of the year tends to be a little higher in terms of the dollar amount we collect because we have a 13 <sup>th</sup> month in the state system, we collect revenue in June that post in July  DUI/DWAI, state offenses as well as state speeding violations go through the Department of Revenue and the Department of Judicial. The department of Judicial receives the funds and then transfer them to Brain Injury program; one lump sum monthly. State offences are managed through County Court.  Municipal speeding conviction surcharges come from the Municipalities and they send us a check.  Debbie asked if there might be revenue available for committees if necessary to implement their goals such as vision and outreach  We have funds available for community outreach and education programs  RFP:  Judy – RFP looking at all services to be included in one Request for Proposal; Intake, eligibility, adult case management, youth education management consultation and outreach into one RFP. 60 MINUTES PROGRAM MOVE JUDY DETTMER

#### Program Move Judy gave an overview of the history of the program location within the Colorado Department of Human Services (CDHS). The program is placed within CDHS via statue but the specific location within CDHS is not indicated. Judy indicated that we have been looking to move the program for the last couple of years from the Department of Vocational Rehabilitation (DVR) primarily because of 'fit and mission', but also about support in terms of availability of support in elevating our program at the executive management level within CDHS and people understanding what we are trying to accomplish. We now have the opportunity to further explore the placement of the program since the Division of Vocational Rehabilitation is moving to the department of Labor and Employment which is being done via legislation initiated by the governor and the JBC. Legislature is re-aligning the federal Work Investment Opportunity Act (WIOA). Judy has met with the following: Deputy Office Director of Community Programs at OBH, Liza Tupa: Office Director of Children Youth and Families, Robert Werthwein, the Division Director of Community Programs at the Office of Early Childhood, Mary Martin; Colorado Department of Public Health and Environment, Shannon Brietzman and Lindsey Myer; and the Office Director of the Office of Community Living at the Department of Health Care Policy and Finance, Jed Zigenhaggen Leo indicated that OBH is very supportive of the program move to the department. Regina, easy transition since we're already within CDHS. Leo. it's the importance of having support as well as structure but also the balance with autonomy as the board wants to be able to work independently and have a specific purpose and values and not have to feel that it has to come within and change the way it operates in order to meet set perimeters within the DISCUSSION Danny, are there any for seeable cons or problems with moving to Health Care Policy and Finance (HCPF) Judy, I see the issue with moving to HCPF is that HCPF is Medicaid focused. It's complicated in terms of both mission and finance. Cash funds vs Medicaid funds and how does that even look in terms of cost Judy, not to go immediately to HCPF as our own little entity. If we go to OBH and they move to HCPF, then you're being moved in with a whole system where we could be more supported. I like the Office of Behavioral Health as my first choice. The Office of Early Childhood, is focused on 0-8 years of age. The department of Public Health primary focus is prevention. Leo, suggest having a conversation with the Office Director of Children Youth and Families Robert Werthwein. OBH - Best fit, mission focused, attention treatment/prevention/substance abuse use/mandate for mental health early intervention, cash fund/drunk driving, law enforcement assistant fund, community providers, health cabinet consist of CDPHE, HCPF, & Human Services, located within CDHS. OBH strong/significant value, jail base, supportive, Administrative side, a lot of touch points with Judicial with regards to cash funds, persistent drunk driver, law enforcement assistant fund, contracts and procurement to community providers throughout the state. CDPHE looks good as well with public health experience and they are supportive however the program and board are hesitant to open legislation/statue. Plan B -backup CDPHE, lean toward the ones within CDHS. The board felt that the program fits best and would be supported best within the Office of Behavioral **CONCLUSIONS** Health at CDHS.
