Overview

Background

MINDSOURCE Brain Injury Network within the Office of Community Access and Independence at the Colorado Department of Human Services (CDHS) contracted with the Colorado Department of Education (CDE) for brain injury support services for FY2019 (July 1, 2018-June 30, 2019). The scope of this work involved building the infrastructure of Colorado schools and the capacity of school personnel and health professionals, and providing support to develop and maintain both school based concussion management and district based brain injury consulting teams. In addition, this contract involved providing the following; general training on brain injury both in the schools, as well as in the community; developing guidelines/protocols, and monitoring and developing appropriate policies related to supporting students with brain injury in the education setting. Finally, this contract involved partnering with community agencies and others at CDE to build the capacity of families to better understand how to support their child with a brain injury. Funding for this work was provided through MINDSOURCE Brain Injury Network, Traumatic Brain Injury (TBI) Trust Fund revenue.

Key Accomplishments for FY2019

- Disseminated information explaining and promoting Return to Learn Concussion Management Teams to administrators and educators at conferences and meetings.
- Facilitated Return to Learn CMT Community of Practice (CoP) Meetings for individuals who completed the CMT training.
- Facilitated Concussion Action Team (CAT) teleconference meetings to keep districts up-to-date on concussion information.
- Provided consultation to school personnel and parents with questions regarding concussion.
- Provided a two-day new BrainSTEPS CO Team/team member training and trained 6 additional BrainSTEPS CO Brain Injury Consulting Teams and 37 new team members to add to existing teams. There are now 26 District and 5 Board of Cooperative Educational Services (BOCES) Level BrainSTEPS CO Teams with 189 team members serving 65 districts in Colorado.
- Provided a one-day up-date training for 146 BrainSTEPS CO team members.
- Provided a one-day BrainSTEPS CO Team Leader Training to enhance the skills of BrainSTEPS CO Team Leaders.
- Held monthly teleconference calls with BrainSTEPS CO Team Leaders.
- Supported BrainSTEPS CO team members through consultation and mentoring.
- Disseminated brain injury information at conferences and professional meetings.
- Maintained the TBI and CAT ListServs, disseminating information on a regular basis.



Key Activities for FY2019

- 1. Develop, implement, and maintain a network of school based CMTs.
 - a. Provide training to, and obtain buy in from, appropriate administrators.

The following activities took place to encourage support for CMTs by administrators and school personnel:

- Promoted the Return to Learn CMT training via dissemination of Return to Learn CMT Rack Cards and Why Your School Needs a CMT flyers distributed to school administrators at a booth manned by Dr. Tyler at the:
 - o Colorado Association of School Executives' Conference, 7/25-26/18, Breckenridge, CO. (Approximately 1,100 school administrators attended this conference.)
 - Colorado Association of School Nurses' Conference, 11/3/18, Loveland, CO.
 - o Colorado School Counselors' Association Conference, 10/18/18, Keystone, CO.
- Presented Return to Learn Concussion Management: Supporting Students through Data-Based Decision Making, Collaboration, and Tiered Supports at the Colorado Society of School Psychologists' 2018 Conference in Keystone, CO, 11/2/18.
- Promoted Return to Learn CMT training during a webinar presentation entitled Return to Learn Following Concussion: Information for School Nurses at the Colorado School Nurses' Orientation on 1/8/19.
- Marketed the Return to Learn CMT training at Concussion Action Team (CAT) Teleconference (8/23/18) and BrainSTEPS CO Team Leader Meetings (8/29/18, 9/26/18). Instructions for registering for the training were given at all CAT and BrainSTEPS CO meetings.
- Provided Return to Learn CMT training information to the Colorado Charter School Institute summer 2018 to disseminate to charter schools in their fall newsletters.
- Communicated with Teresa Tate, VP of School Services, at the Colorado League of Charter Schools, and sent her BrainSTEPS CO Return to Learn CMT literature, including BrainSTEPS CO Return to Learn CMT Rack Card and Why Your School Needs a CMT to distribute to Charter Schools.
- Applied to present/exhibit Return to Learn CMT information at FY2020 conferences (e.g., Colorado Association of School Executives, Colorado Association of School Counselors, and Colorado Association of School Nurses).
- b. Develop CMTs in a minimum of 100 schools.



As shown in the table below, at the end of FY2019, 159 CMTs were registered for the CMT training (with 278 individuals on those teams). Additionally 175 BrainSTEPS CO Team Members were registered for the CMT training. Thirty-two districts have one or more Return to Learn CMTs.

- c. Conduct Monthly Concussion Management Team (CMT) Meetings
 - To help support the Return to Learn CMTs once they have completed the training, Return to Learn CMT Community of Practice (CoP) Monthly Meetings are held. These meetings are open to all persons who have finished the Return to Learn CMT online training. The meetings are co-hosted by Dr. Brenda Eagan Johnson, Director of the BrainSTEPS Pennsylvania program, and Dr. Tyler. The purposes of the online meetings are to provide answers to any questions participants may have regarding concussion management and to disseminate new concussion research. During each meeting a PowerPoint presentation was delivered highlighting concussion research, concussion resources, case studies, and strategies for Return to Learn. Participants were encouraged to ask questions about Return to Learn concussion management. PowerPoint presentations from each meeting are available upon request.

The March and April meetings were cancelled due to urgent commitments that occurred for both Drs. Eagan Brown and Tyler. The November and May meetings were held by Dr. Tyler as Dr. Brown was holding other trainings.

d. Conduct bi-monthly Concussion Action Team (CAT) meetings.

CAT teleconference meetings are held bi-monthly during the school year to provide school professionals an opportunity to discuss challenges, share information/documents, and share



achievements related to concussion management. In addition, CDE provides updates and facilitates discussion of current research articles and new materials produced within the brain injury field. Five CAT teleconference meetings were held during the FY19 school year. The table below shows CAT teleconference dates, number of persons attending via GoToMeeting, and the number of districts represented:

Persons from the following 19 school districts participated in CAT meetings during FY19: Academy 20, Aspen, Aurora Public Schools, Boulder Valley, Cherry Creek, Colorado Springs 11, District 27J, District 49, District 70, Douglas County, Englewood Schools, Gunnison Community Schools, Jefferson County, Littleton Public Schools, Manitou Springs, Mesa County Valley 51, Pueblo City 60, St. Vrain Valley Schools, and Swink. Additionally, minutes from the CAT meetings were emailed to over 384 school district members on the CAT Listserv. The minutes contained concussion resources and links to research articles and resources discussed during the CAT conference call.

- e. Update CDE Concussion Guidelines as necessary annually and disseminate these guidelines both in Colorado and nationally.
 - While work continues on updating 2014 Colorado Department of Education Concussion Management Guidelines, contacts and links have been updated in the online version (found on the CDE http://www.cde.state.co.us/healthandwellness/braininjury and CoKids https://cokidswithbraininjury.com/ webpages.)
 - The 2018 edition of the Brain Injury in Children and Youth: A Manual for Educators, which had been in the process of being updated for the last year, was completed. The final manual was posted on the CDE and CoKids' websites, announced through the Brain Injury Listserv and publicized at all trainings. A small number of hard copies of the manual have been printed and distributed.
 - Return to Learn Concussion Consultation: School district personnel and parents frequently call requesting information regarding issues related to concussion. During FY19, consultation was provided to 32 persons regarding return to learn concussion matters, developing district concussion policies, identification of concussions, etc., via email/phone. Notes or email document each individual occurrence.



- 2. Develop, implement, and maintain a network of BrainSTEPS Teams across the state.
 - a. Develop and implement BrainSTEPS CO New Team trainings two times per year (fall and spring).

The following actions were taken to prepare for the BrainSTEPS CO new team training:

- Developed and disseminated BrainSTEPS CO District/BOCES Brain Injury Consulting Teams
 rack card and Why Your District Needs a BrainSTEPS CO Team information sheet to
 administrators at the Colorado Association of School Executives' Conference 7/25/18 and
 7/26/18 in Breckenridge, Colorado.
- Recruited districts who were without BrainSTEPS CO teams (e.g., Denver Public Schools, Adams 12, Moffat County) through discussions with appropriate district personnel.
- Developed 2018 application for BrainSTEPS CO New Team Training and posted applications on the BrainSTEPS CO website and CDE Health & Wellness and Exceptional Student Services Unit websites.
- Posted notices of the BrainSTEPS CO New Team Training on the CDE's Weekly Newsletter (6/13/19, 8/1/18, 8/15/18, 9/12/18,) TBI ListServ, School Nurse's ListServ, and in the Exceptional Student Services Newsletter.
- Disseminated information regarding the New Member BrainSTEPS CO Team Training to current BrainSTEPS CO team members.
- Made arrangements for the BrainSTEPS CO November 2018 new team training (venue and speakers booked, agenda set, training materials developed, etc.)

BrainSTEPS CO New Team/Team Member Training

The 79 applications that were received before the 9/14/18 deadline were reviewed and notices were sent to those that were accepted for the training and those that were not. New teams from 6 districts and 1 BOCES applied for the BrainSTEPS CO team training. Of the 7 new teams that applied, 6 were accepted. One team only had 2 people apply, and after working with them to get more people on board, it was decided that they would wait and reapply at a later date. There were also 4 interns and a paraprofessional who applied that were not accepted for the training because of the need to accept persons who can best fulfill the *BrainSTEPS Co Best Practices Guidelines*. There were also 14 existing district/BOCES teams that wanted to add additional members to their teams and 37 individuals from those team completed applications and were accepted for training (see Districts/BOCES attending November 14-15, 2018 BrainSTEPS CO New Team Training Table on page 8).

The BrainSTEPS CO New Team training (see Appendix A for Agenda) was held at the Lowry Conference Center in Denver on 11/14-15/18. A total of 69 Colorado school district personnel from 20 districts/BOCES attended the training to become BrainSTEPS CO team members.



Participants included school nurses, instructional specialists, special education teachers, occupational therapists, physical therapists, speech language therapists, school psychologists, school social workers, a Director of Health Wellness and Prevention, and a Director of Special Services. A BrainSTEPS CO Team Leader who had all new team members joining her team also attended the training so she could be there to help plan with and support her new team members. Additionally, the Youth Education Liaison from the Brain Injury Alliance of Colorado, attended the training.

While the main content for the two-day training was delivered by the CDE brain injury consultants, Janet Tyler, Heather Hotchkiss, and Nicole Crawford, Judy Dettmer was invited to come and provide an overview of MINDSOURCE Brain Injury Network. Additionally, community partners with whom the teams are likely to have frequent interactions, were invited to present an overview of their programs. These presenters included Jodi Krause and Erin Austin from Children's Hospital, Laura Magnuson from Craig Hospital, and Cari Ledger from BIAC. All persons who were accepted for the November BrainSTEPS CO New Team



Training were sent a link to complete an online *Knowledge about Children and Youth with Brain Injury* pretest prior to the training. A total of 69 persons completed the pre-test. Following the training, participants were asked to complete the *Knowledge about Children and Youth with Brain Injury* post-test. A total of 67 persons completed the post-test.

Scores were compared with those who took both the pretest and the post-test, and as a group; participants scored 71% on the pretest and 87% on the post-test, showing a 16% gain in knowledge. On all questions, participants showed an increase in score. Where the score increase was only minimal (indicating not all participants had a thorough understanding of the concept), those topics will be reviewed at the update training in February.

Participants were also expected to complete the BrainSTEPS CO Brain Injury New Team Training Evaluation survey. In an effort to increase participation, participants were told at the training that they would have a chance to be entered into a drawing for a \$50 Lash & Associates gift certificate by completing both the post test and evaluation. A total of 65 individuals completed the evaluation survey (94% completion rate). The survey asked participants to respond to the following 4 statements for presentations covered in the two-day training, rating each 1) Strongly Disagree, 2) Disagree, 3) Agree, or 4) Strongly Agree.

A final open ended question asked respondents, "What types of additional information or followup activities should be provided?" Information received from this question will be used when planning future trainings.

BrainSTEPS CO Up-Date Training

A BrainSTEPS CO all team Update Training was held at the Cherry Creek Fremont Building in Centennial, Colorado on 2/21/19 (see Appendix B for BrainSTEPS CO Update Training Agenda). A total of 146 BrainSTEPS CO team members attended the training to increase their knowledge in brain injury and skills in serving as BrainSTEPS CO team members. In addition to presentations by CDE BrainSTEPS CO staff, Lori Cook, Ph.D., Director of Clinical Research, Center for BrainHealth, University of Texas at Dallas, was contracted to provide a half-day training entitled Strategies for Life: Promoting Higher-Order Cognitive Skills for Students with TBI across Contexts. Russha Kaauer, MA, a Management Analyst with the Division of Probation Services in the State Court Administrator's Office in Denver also provided a presentation on how individuals with brain injury interact with the criminal justice system.

All persons who registered for the training were sent a link to complete an online *February 2019 BrainSTEPS CO Update Training Pre-Test* prior to the training. The pretest was composed of questions submitted by the invited speakers and the CDE BrainSTEPS CO staff. A total of 139 persons completed the 10 question pre-test. Following the training, participants were asked to complete the *February 2019 BrainSTEPS CO Update Training Post-Test*. 133 persons completed the 10 question post-test (91% completion rate).

Scores were compared for those who took the pretest and the post-test, and as a group participants scored 72% on the pretest and 86% on the post-test, showing a 14% gain in knowledge.

All participants were also expected to complete the BrainSTEPS CO Brain Injury Update Training Evaluation survey. A total of 133 individuals completed the evaluation survey (91% completion rate). The survey asked participants to respond to the following 4 statements for presentations covered in the training; rating each: 1) Strongly Disagree, 2) Disagree, 3) Agree, or 4) Strongly Agree. The table on page 12 shows the team members responses.

Additionally open ended questions asked respondents, ""Overall, I thought this training was:"; "What types of additional information or follow-up activities should be provided?"; "Anything additional?" Information received from these questions will be used when planning future trainings.



BrainSTEPS CO Team Leader Training

Each of the BrainSTEPS CO teams has a designated team leader or co-team leader. To increase team leaders' knowledge of brain injury and to provide them with strategies for effectively leading their BrainSTEPS CO teams, a BrainSTEPS CO Team Leader Training was held at the Front Range Community Center in Westminster on April 24, 2019. The agenda for the BrainSTEPS CO Team Leader training is found in Appendix C.

Twenty-Seven Team Leaders from the following 21 BrainSTEPS CO teams attended (one or two leaders from each team attended, as noted in the parentheses following each team): Academy 20 (1), Aurora 28J (1), Boulder Valley (2), Centennial BOCES (1), Cherry Creek (2), Colorado River BOCES (1), Denver County (2), Douglas County (1), Englewood (2), Falcon 49 (1), Harrison 2 (1), Jefferson County (1), Poudre (1), Pueblo County 70 (2), Santa Fe Trail BOCES (1), School District 27J (2), St. Vrain Valley (1), Thompson (1), and Ute Pass BOCES (1). Seven BrainSTEPS CO Team Leaders could not attend due to prior commitments in their districts. Following the training, all presentations and handouts were posted on the BrainSTEPS CO website for team members to view, so those who were not able to attend had access to the information.

Following the training, participants were emailed a link to complete the *BrainSTEPS CO Team Leader Training Evaluation* Survey. Twenty-seven of the 27 attendees completed the evaluation (100% completion rate.) The survey asked participants to respond to 6 statements evaluating the speakers, content, training activities, etc. rating each: 4) Strongly Agree 3) Agree, 2) Disagree, or 1) Strongly Disagree, with a rating of Strongly Agree being a positive rating and Strongly Disagree being a negative rating of the training. The table below shows the team leaders' responses to the survey.

There was also one open ended question that asked participants for "Additional Comments (e.g., general comments regarding the training, topics for future Team Leader Trainings, etc.)." Examples from the "Additional Comments" question included the following responses from Team Leaders:

- "I got a lot of new ideas for team meetings and increasing our visibility in the district and community. As always, very helpful."
- "Loved the team leader training. I think my favorite was the presentation by Dr. Gorgen-- she was fabulous. However, I felt I learned a lot in general and am excited to begin my role as a co-team lead for our district BrainSTEPS team."
- "Great day! Appreciate all of your support of our team!"

b. BrainSTEPS CO Team Support

Team Leader Meetings are held monthly via GoToMeeting to update the team leaders with new information, announcements, etc. This also provides them an opportunity to ask any questions they may have regarding BrainSTEPS CO procedures, management of students with TBI, etc. The meeting begins with announcements and updates being disseminated through a PowerPoint presentation. The meeting then opens up to a question and answer session and general discussion. Minutes from each of the BrainSTEPS CO Team Leader Monthly Conference calls are sent to all team leaders following the call and are posted on the BrainSTEPS website.

Monthly meetings were not held in February or April because in-person BrainSTEPS CO meetings were held during those months. In May, information was sent via email, as team leaders voiced it



would be difficult for them to make the May monthly meeting given their schedules at the end of the school year.

It is important that BrainSTEPS CO team leaders and team members have expert support available as they carry out their role. During FY19, Dr. Tyler responded to approximately 84 phone calls and emails from BrainSTEPS CO team leaders and team members seeking information or guidance on various aspects of serving students with brain injury.



As an additional means of providing support to the BrainSTEPS CO teams, the CDE BrainSTEPS CO staff (Tyler and Hotchkiss) began plans to attend one of each team's monthly meetings. During FY19 Dr. Tyler attended the following BrainSTEPS CO team meetings listed in the table below.

c. Conduct Annual Survey of BrainSTEPS CO Teams

Two surveys were conducted during FY19. The first survey was sent to team leaders on 3/11/19 in an effort to determine what type of financial supports (if any) the BrainSTEPS CO teams were receiving from their districts. Responses were received from 25 of the 26 BrainSTEPS teams (96% response rate). The questions from the Quick Survey and the results are found below.

- Q.1) Does your district/BOCES pay any of your BrainSTEPS CO members any FTE for serving on the BrainSTEPS CO team? If yes, how many/how much?
 - Results:
 - 5 districts pay their team leaders some FTE.
 - One district pays both team leaders some FTE.
 - Amount of FTE = 1.0, .2 (two teams), .05, .01
- Q.2) Does your district/BOCES pay any of your BrainSTEPS CO members a stipend for serving on the BrainSTEPS CO team? If yes, how many/how much?

Results:

- Three districts/BOCES pay all their BrainSTEPS CO team members stipends.
- Stipend amounts ranged from \$200-\$500 and are dependent on the district/BOCES budget for the year.
- Q.3) Who is primarily responsible for overseeing the BrainSTEPS program in your district (e.g., SPED, Professional Development, Learning Services).

Results:

- In the majority of cases (15) Special Education is the administrative unit responsible (or jointly responsible) for the BrainSTEPS CO team in the districts.
- Other units include Health Services, Mental Health, Speech-Language, etc.
- Two team leaders reported that no one was responsible for overseeing the BrainSTEPS CO team besides themselves.



Results of this survey were shared with team leaders at the April 2019 BrainSTEPS CO Team Leader Training. Discussions took place regarding how districts with low levels of support from administration could possibly gain additional support.

A link to the second survey, the *BrainSTEPS Team Member Satisfaction Survey*, was emailed to all team members on 4/3/19. Ninety-four of the 190 BrainSTEPS CO team members responded (49% response rate). At least one person from each team responded and one team had all seven members respond. Responses to the *BrainSTEPS Team Member Satisfaction Survey* are found in the table below.

- 3. Activities Related to Maintaining a Data Base for both CMT and BrainSTEPS CO Team Data
 - Communications occurred with Tim Kelly of Leader Services to make necessary changes to
 update dates on the home page, move team members from one district to another, set up
 five new teams in the ORBS database, etc.

Barriers/Challenges Faced (in Terms of Meeting SOW) for FY2019

All tasks in the Statement of Work were completed in FY2019. However, challenges continued in the area of securing administrative support for the Return to Learn CMT training. Ongoing work is needed to dispel administrators' misperceptions that athletic trainers always provide return to learn care for *all* students and that all school personnel are knowledgeable regarding academic adjustments following concussions.

Plans for FY2020

Plans for FY2020 are to continue to ensure that Colorado students with brain injuries are served by educational personnel that are trained to meet their unique cognitive, behavioral, and physical needs. To do so, additional BrainSTEPS CO Brain Injury Consulting teams will be trained in FY2020 and existing BrainSTEPS CO team members will be supported through ongoing training and consultation. Furthermore, additional Return to Learn CMT's will be trained to manage the academic needs of the numerous students returning to learn following concussion and previously trained Return to Learn CMT's will be kept up-to-date and supported through monthly Community of Practice teleconference meetings and consultation.
