### **OVERVIEW**

#### Background

MINDSOURCE Brain Injury Network within the Office of Community Access and Independence at the Colorado Department of Human Services (CDHS) contracted with the Colorado Department of Education (CDE) for brain injury support services for FY2021 (July 1, 2020, through June 30, 2021). The scope of this work involves building the infrastructure of Colorado schools and the capacity of school personnel and health professionals; providing support to develop and maintain both district based BrainSTEPS CO brain injury consulting teams and school based Return to Learn Concussion Management Teams (CMTs). In addition, this contract involved providing the following: general training on brain injury, both in the schools, as well as in the community; developing guidelines/protocols, and monitoring and developing appropriate policies related to supporting students with brain injury in the education setting. Finally, this contract involves partnering with community agencies and others at CDE to build the capacity of families to better understand how to support their child with a brain injury. Funding for this work is through the MINDSOURCE Brain Injury Network, provided by the Colorado Traumatic Brain Injury Trust Fund revenue.

### **KEY ACCOMPLISHMENTS FOR FY2021**

- Provided a virtual three-day New BrainSTEPS CO Team/Team Member Training, preparing one additional BrainSTEPS CO Brain Injury Consulting Team and 31 new team members to add to existing teams. There are now 22 District and five Board of Cooperative Educational Services (BOCES) Level BrainSTEPS CO Teams with 210 team members serving 64 districts in Colorado (approximately 70-75% of the student population).
- Held a one-day virtual Up-Date Training for BrainSTEPS CO team members with 174 team members attending.
- Provided a virtual Team Leader Training for BrainSTEPS CO team leaders with 36 team leaders attending.
- Provided additional training opportunities for BrainSTEPS CO members including the Online Reporting for BrainSTEPS (ORBS) Database training and the Helix Conference Brain Injury Sessions.
- Held monthly teleconference calls with BrainSTEPS CO Team Leaders.
- Supported BrainSTEPS CO team members through consultation and mentoring.
- Disseminated brain injury information virtually at conferences and professional meetings.
- Disseminated information explaining and promoting Return to Learn Concussion Management Teams to administrators and educators virtually at conferences and meetings.
- Provided monthly Return to Learn CMT Community of Practice (CoP) online webinars/meetings
  featuring nationally known concussion expert guest speakers, to keep the knowledge of individuals
  who have completed the CMT training up-to-date.



- Held bi-monthly Concussion Action Team (CAT) teleconference meetings to keep districts up-to-date on concussion information.
- Provided consultation to school personnel and parents who had questions or concerns regarding concussion.
- Maintained the Traumatic Brain Injury (TBI) and CAT listservs, disseminating information on a regular basis.
- Maintained the Colorado Kids with Brain Injury (<a href="www.cokidswithbraininjury.com">www.cokidswithbraininjury.com</a>) and CDE brain injury (<a href="http://www.cde.state.co.us/healthandwellness/braininjury">http://www.cde.state.co.us/healthandwellness/braininjury</a>) websites.

### **KEY ACTIVITIES FOR FY2021**

- 1. Develop, implement, and maintain a network of BrainSTEPS CO Teams across the state through BrainSTEPS CO team trainings.
  - a. Develop and implement a two-day BrainSTEPS CO New Team Member training fall 2020.

The following actions were taken to prepare for the BrainSTEPS CO New Team/Team Member training:

- Posted notices of the BrainSTEPS CO New Team/Team Member Training in the CDE's Weekly Newsletter, TBI listserv, School Nurse listserv, and in the Exceptional Student Services Online Newsletter.
- Recruited districts who were without BrainSTEPS CO teams (e.g., Weld RE-6) through discussions with appropriate district personnel.
- During BrainSTEPS CO Team Leader Monthly Meetings, team leaders were encouraged to
  evaluate their team's composition and send additional district personnel to the November
  training if they needed additional members to grow their team or replace team members who
  had retired or moved away.
- Converted the in-person two-day BrainSTEPS CO New Team Training curriculum used in past years, to a virtual training to meet current needs of educators during the COVID-19 pandemic.

### **BrainSTEPS CO New Team/Team Member Training**

A BrainSTEPS CO New Team/Team Member Training was held virtually via Zoom, November 10th, 11th, and 12th, 2020 (see Appendix A for Agenda). A total of 36 Colorado school district personnel from 16 districts and BOCES, attended the virtual training to become BrainSTEPS CO team members (see BrainSTEPS CO New Team Training November 10-12, 2020, table below). Participants included district nurses, school nurses, behavioral specialists, instructional specialists, occupational therapists, physical therapists, speech language therapists, school psychologists, school social workers, an

educational diagnostician, a head athletic trainer, a Student Support Services Coordinator, and a Special Education Coordinator. Additionally, upon request, Jessica Hall, the new classroom teacher on the Rehabilitation Unit at Colorado Children's Hospital attended the 3-day training to increase her knowledge of working with students with brain injuries and the BrainSTEPS CO program.

The table below shows a listing of the number of attendees from each of the BrainSTEPS districts and BOCES teams that were trained in November 2020. New teams are noted in bold and marked with an asterisk\*.

The main content for the two-day training was delivered by the CDE brain injury consultants, Janet Tyler, Heather Hotchkiss, and Nicole Crawford. Additionally, Liz Gerdeman, provided an overview of THE MINDSOURCE Brain Injury Network, and each of the community partners with whom the teams are likely to have frequent interactions presented a 10-minute overview of their programs and how they coordinate with the BrainSTEPS CO teams. The community partners included Kate Fatica from BIAC, Jodi Krause from Colorado Children's Hospital, and Laura Magnuson from Craig Hospital.

**TOTAL** 

All persons who were registered for the November BrainSTEPS CO New Team Training were sent a link to complete an online *Knowledge about Children and Youth with Brain Injury Pretest* prior to the training.



A total of 35 persons completed the pre-test. Following the training, participants were asked to complete the *Knowledge about Children and Youth with Brain Injury Post-Test*. A total of 34 persons completed the post-test (97% completion rate for those attending the training).

Scores were compared with those who took both the pretest and the post-test. As a group, participants scored 68% on the pretest and 88% on the post-test, showing a 20% gain in knowledge.

Participants were also expected to complete the BrainSTEPS CO Brain Injury New Team Training Evaluation Survey. A total of 32 persons completed the evaluation survey (89% completion rate). The survey asked participants to respond to the following 10 statements for presentations covered in the two-day training, rating each: 1) Strongly Disagree, 2) Disagree, 3) Agree, or 4) Strongly Disagree. The table below shows the survey questions, the number of responses, and percentages in each category.

### **Helix Brain Injury Conference**

Annually, Pennsylvania's Training and Technical Assistance Network (PATTAN) sponsors a low incidence conference that includes a brain injury strand selected by Pennsylvania's BrainSTEPS director, Dr. Eagan-Johnson. This year the strand served as the required up-date training for Pennsylvania's BrainSTEPS teams. The 2020 HELIX Conference: High Expectations for Students with Low Incidence Disabilities, was held virtually, and was free of charge for Pennsylvania residents. Dr. Tyler arranged with Dr. Eagan-Johnson that Colorado BrainSTEPS team members could also participate in the brain injury sessions free of charge. The training was announced at the September and October team leader meetings and registration information was sent out to all team members on 10/12/20. Between 53-72 BrainSTEPS CO team members attended each of the three sessions listed below.

### Online Reporting for BrainSTEPS (ORBS) Database Training

With the New Team/Team Member training being moved to a virtual platform, the ORBS database training, which was usually a part of the in person training, was changed to a stand-alone training. This training was mandatory for all persons who attended the November 2020 New Team/Team Member training and recommended for all team members who wanted a refresher course on using the BrainSTEPS database. Dr. Nicole Crawford delivered the content of this training.

b. Develop and implement a BrainSTEPS CO Up-Date training spring 2021.
 Topics for the 2021 BrainSTEPS CO Update Training were chosen based on feedback given by team members on the 2020 Update Training Evaluation.

A BrainSTEPS CO Update Training was held virtually for all BrainSTEPS CO team members on February 11, 2021. 174 BrainSTEPS CO team members from 27 districts/BOCES attended the training to increase their knowledge of brain injury and skills in serving as BrainSTEPS CO team members. In addition to updates provided by CDE BrainSTEPS CO staff Tyler and Hotchkiss, Sharon Grandinette, M.S., Ed., CBIST, presented a morning session entitled *Students with ABI: Filling Your Toolbox with* 



Interventions and Strategies for Success and Shari L. Wade, Ph.D., a pediatric rehabilitation psychologist at Cincinnati Children's Hospital Medical Center and tenured professor at the University of Cincinnati College of Medicine, presented an afternoon session entitled *Using Teen Online Problem Solving to Support Adolescents and Families after Brain Injury*. All persons who registered for the training were sent a link to complete an online *February 2021 BrainSTEPS CO Update Training Pre-Test* prior to the training. The pretest was composed of questions submitted by the invited speakers. A total of 160 persons completed the 10 question pretest. Following the training, participants were asked to complete the *February 2021 BrainSTEPS CO Update Training Post-Test*. 122 persons completed the 10 question post-test (76% completion rate).

Scores were compared for those who took the pretest and the post-test (N=122). As a group participants scored 60% on the pretest and 73% on the post-test, showing 13% gain in knowledge. All participants were also expected to complete the BrainSTEPS CO Brain Injury Update Training Evaluation Survey. A total of 112 individuals completed the evaluation survey (64% completion rate). The survey asked participants to respond to the following 6 statements for presentations covered in the training; rating each: 1) Strongly Agree, 2) Disagree, 3) Agree, or 4) Strongly Disagree. The table below shows the survey questions and the number of responses and percentages in each category.

After the training was completed, all presentations and handouts were posted on the BrainSTEPS CO website for team members to view, so those who were not able to attend had access to the information.

c. Develop and implement a BrainSTEPS CO Team Leader training spring 2021.

A BrainSTEPS CO Team Leader Training was held virtually via Zoom on April 29, 2021. One to three team leaders from each of the 27 teams attended the BrainSTEPS CO Team Leader training to gain strategies and hone their skills in serving as BrainSTEPS CO team leaders (see Appendix C for copy of BrainSTEPS CO Team Leader Training Agenda).

### **Monthly Team Leader Meetings**

BrainSTEPS CO Team Leader meetings were held monthly via Zoom to update the team leaders with new information, announcements, etc. This provided team leaders with an opportunity to ask any questions they may have regarding BrainSTEPS CO procedures, management of students with TBI, etc. Each meeting started with announcements and updates being disseminated through a PowerPoint presentation. The meeting then opened to a question and answer session, followed by a general discussion. Minutes from each of the BrainSTEPS CO Team Leader Monthly Conference calls are sent to all team leaders following the call and are posted on the BrainSTEPS website where they are available to be view by all Colorado BrainSTEPS team members. Team leaders are instructed to share information from the meetings with their teams during their own team's monthly meetings.

### **BrainSTEPS CO Team Member Consultations**

It is important that BrainSTEPS CO team leaders and team members have expert support available as they carry out their role. Dr. Tyler responded to approximately 115 phone calls and emails from BrainSTEPS CO team leaders and team members seeking information or guidance on various aspects of serving students with brain injury during FY21. Emails and notes from phone calls document these consultations.

As an additional means of providing support to the BrainSTEPS CO teams, the CDE BrainSTEPS CO staff (Tyler and Hotchkiss) continued plans from FY20 to attend one of each team's monthly meetings. During quarter one, BrainSTEPS CO team leaders were asked to provide their team meeting schedules to the CDE BrainSTEPS CO leaders so they could schedule virtual team visits. The table below shows the BrainSTEPS CO team meetings that Dr. Tyler attended during quarters two, three, and four. Notes from each meeting attended are kept on a shared drive that both Tyler and Hotchkiss can access.

#### **Materials for BrainSTEPS CO Team Members**

Drs. Tyler and Eagan-Johnson, Pennsylvania BrainSTEPS Project Director, developed a series of 26 support pages to accompany the Student Brain Injury Supports Framework. These two-page documents each contain a page with a fillable word form to guide the discussion of post-concussion symptoms or changes the student is having that are causing him or her difficulty in school (e.g., in what environment they occur, activity triggers, currently used academic adjustments, additional adjustments to explore). The accompanying page provides a separate list of strategies and adjustments educators can use to help the student during the recovery phase for 26 possible physical, thinking, learning, behavioral, and social concussion symptoms. These documents were shared with BrainSTEPS CO team leaders and are posted on the Colorado BrainSTEPS webpage for team members to download and share with educators.

### **BrainSTEPS CO Team Member Survey**

At the end of March 2021, an annual survey of BrainSTEPS CO team members was conducted by Dr. Tyler. A link to the survey was emailed to all 216 BrainSTEPS CO team members. One hundred and three persons responded (67 BrainSTEPS CO team members and 36 BrainSTEPS CO team leaders) for a response rate of 48%. The table below shows the survey questions and the number of responses and percentages in each category. At least 1 response was received from 25 out of the 27 BrainSTEPS CO teams.

- 2. Develop, implement, and maintain a network of school-based concussion management teams (CMTs).
  - a. Provide training to, and obtain buy in from, appropriate administrators and school building personnel.

The following activities took place during FY21 to encourage administrative support for CMTs and to get appropriate groups to register for the training:

- The Return to Learn CMT training was promoted at the Concussion Action Team (CAT) Teleconference (8/27/20, 2/25/21) and BrainSTEPS CO Team Leader Teleconference Meetings (8/19/20, 9/16/20, 2/24/21, 3/17/21).
- Instructions on how to sign up for the CMT training was included in the CAT minutes sent out to the CAT listserv.
- The Return to Learn CMT training was promoted through a virtual BrainSTEPS CO booth staffed by Dr. Tyler at the Colorado School Counselor Association Virtual Conference (10/8-9/20).
- Return to Learn CMT training was promoted during a webinar presentation entitled *Return to Learn Following Concussion: The Role of the School Nurse* at the Colorado School Nurses' Orientation (3/2/21).
- b. Develop CMTs in a minimum of 25 schools.

### c. Conduct monthly Return to Learn CMT Community of Practice (CoP) meetings.

To help support the Return to Learn CMTs once they have completed the training, Return to Learn CMT CoP Monthly Meetings were held. These meetings were open to all persons who completed the Return to Learn CMT online training. The meetings were cohosted by Drs. Tyler and Eagan-Johnson, Director of the BrainSTEPS Pennsylvania program. The purposes of the online meetings were to disseminate new concussion research and to provide answers to questions participants may have regarding concussion management. During each meeting, a PowerPoint presentation was delivered highlighting concussion research, concussion resources, case studies, and strategies for Return to Learn. Participants were encouraged to ask questions about Return to Learn concussion management. PowerPoint presentations from each meeting are available upon request.

Starting in the second quarter, Drs. Tyler and Eagan-Johnson arranged to have nationally known speakers on a variety of topics in the field of concussion present at the Return to Learn Concussion Management Community of Practice Meetings. Persons who have completed the Return to Learn CMT training received a monthly invitation for each meeting.

d. Conduct bi-monthly Concussion Action Team (CAT) meetings.

CAT teleconference meetings are held bi-monthly during the school year to provide school professionals an opportunity to discuss challenges, share information/documents, and share achievements related to concussion management. In addition, the CDE provides updates and facilitates discussion of current research articles and new materials produced within the brain injury field. Additionally, minutes from the CAT meetings are emailed to over 400 school district members on the CAT Listserv. The minutes contain concussion resources and links to research articles and resources discussed during the CAT conference call.

- e. Assist districts with developing concussion guidelines.
  - During FY21 assistance was provided to two districts developing concussions guidelines. Dr.
     Tyler consulted with a school nurse from Ridgway School District who was assisting her district
     in developing a concussion policy and she consulted with a BrainSTEPS CO team leader in the
     Thompson School District who was heading her district concussion protocol development team.
- 3. Activities related to maintaining a database for both CMT and BrainSTEPS CO Team data.
  - To ensure the security of the BrainSTEPS CO database it is important that only current BrainSTEPS CO team members have access to the Online Reporting for BrainSTEPS (ORBS). Thus, at the beginning of the school year an email was sent to each of the BrainSTEPS CO team leaders providing them with a current list of their team members who had access to their district's ORBS database information, stating they were required to notify Dr. Tyler if any of the members listed were no longer on the team. After team leaders responded, Dr. Tyler ensured that members who had left the district or team, no longer had access to the BrainSTEPS CO database.
  - Responded to requests from Return to Learn CMTs to add and delete individuals from their teams and to help CMTs problem solve user errors.
  - Created a new Weld-6 team in the ORBS database and added the names and contact information for 36 team members trained at the November 2020 new team training to the ORBS database.
  - Worked with Sam Cartos of Frameweld to update the BrainSTEPS CO team leader contact list on the CMT website.



- Worked with Tim Kelly from Leader Services to correct minor issues team members were experiencing with the database.
- Secured FY22 contracts for hosting/maintenance and licensing of the BrainSTEPS CO ORBS database and the Return to Learn Concussion Management training websites.

The Colorado Kids Brain Injury Resource Network (COKids) webpage (<a href="https://cokidswithbraininjury.com">https://cokidswithbraininjury.com</a>) serves as a resource for educators, school administrators, school psychologists, related services professionals, and families.

Maintenance and updates (e.g., to fix broken links) on the website, were provided during FY21 by Dr. Tyler. Additional edits, and revisions to prevent spam, were also made during FY21 by the webmasters at Harmony Designs.

Dr. Tyler also worked with the webmasters at Harmony Design to secure a 5 year renewal on the COKids domain which was expiring in 2020. Upon Harmony Design's recommendation, the domain hosting for COKids was moved from GoDaddy to hover.com for better pricing and customer service.



### BARRIERS/CHALLENGES FACED (IN TERMS OF MEETING SCOPE OF WORK) FOR FY2021

Ongoing presence of the COVID-19 pandemic in FY21 not only continued to disrupt in-person learning for students, but disrupted plans for in-person BrainSTEPS CO trainings, visits to teams, and in-person presentations or displays at conferences. While fortunately most of the work was able to be carried out virtually, it is believed that willingness of school staff to take on an additional role such as a BrainSTEPS CO team member or Concussion Management Team Member suffered because of the pandemic. For example, school nurses, one of our most valued assets on both BrainSTEPS CO teams and Concussion Management Teams, simply did not have the time to attend trainings to become new consulting or concussion team members because they were so busy with COVID-19 related activities in their schools.

#### **PLANS FOR FY2022**

FY22 plans are to continue to provide training and support for BrainSTEPS CO team members and the Return to Learn CMTs so they can best meet the needs of Colorado students with brain injury. Additional BrainSTEPS CO teams, BrainSTEPS CO team members, and the Return to Learn CMTs will be trained to ensure coverage for Colorado school buildings and districts. The introduction of a modest stipend for team leaders in FY22 will provide recognition of the time and effort that BrainSTEPS CO team leaders spend to ensure the success of their teams.

#### **Guest Speakers:**

Sharon Grandinette, M.S., Ed., CBIST is a Certified Brain Injury Specialist/Trainer and a nationally/internationally recognized consultant who focuses her work on school reintegration for children with acquired brain injury, is contracted with school districts to provide ABI consultation services, provides advocacy to families, and expert witness services to attorneys in pediatric ABI legal cases. Sharon worked in public schools as a special educator and administrator for over 20 years, developed and administrated 2 private special education schools for children with acquired brain injury, and spent 3 years as director of a children's post-acute brain injury rehabilitation program that included a school program. Sharon taught as adjunct instructor in the graduate special education department for California State University Dominguez Hills for 18 years. She was instrumental in developing the TBI authorization for the California Department of Education and has written articles and a book chapter on the topic of children's brain injury. Sharon currently serves on the board of the North American Brain Injury Society (NABIS), the National Children's Collaborative on Brain Injury (NCCBI), and has previously served on the boards of BIA California, and BIAA's Academy of Certified Brain Injury Specialists. She is a member of the



International Pediatric Brain Injury Society and is on the planning committee for their 2022 conference. In 2018, Sharon was awarded the 2018 Clinical Innovator Award by the North American Brain Injury Society.

Shari L. Wade, Ph.D., is a pediatric rehabilitation psychologist at Cincinnati Children's Hospital Medical Center and a tenured professor at the University of Cincinnati College of Medicine. Dr. Wade has conducted federally-funded research examining outcomes of pediatric traumatic brain injury and factors that influence outcomes since 1991. This research has been widely cited and shaped how the field understands the role of social environmental factors on recovery and the effects of TBI on child and family functioning over time. For the past 21 years, she has conducted single site and multicenter randomized clinical trials of interventions to reduce morbidity following pediatric traumatic brain injury, including some of the first Class 1 clinical trials for pediatric TBI. She has developed and tested technology-based interventions to reduce behavioral morbidity and family consequences of pediatric TBI for nearly two decades, beginning with an R21 award from NICHD in 2001. Dr. Wade is also leader in multi-center clinical trials for pediatric TBI and served as the principal investigator (PI) and director of the Rehabilitation Research and Training Center (RRTC) for Pediatric Brain Injury Interventions, the only federally-funded center for pediatric TBI.
